Liability Information: In consideration of the David A. Straz, Jr. Center for the Performing Arts' agreement to have the Student participate at The Patel Conservatory, which includes third party bus transportation to and from The Patel Conservatory, and realizing that there are potential risks involved with the transportation of the Student to and from The Patel Conservatory and that participation in production(s) and/or class sessions at The Patel Conservatory may involve physical activities, all of which might result in injury and death to the Student, I/we, the Student and the parent(s) and/or legal guardian(s) of the Student, jointly and severally, do hereby hold harmless and release the David A. Straz, Jr. Center for the Performing Arts from any and all liability for any injuries, death or illnesses or the loss and/or damage to any personal property arising, directly or indirectly, from transportation to and from The Patel Conservatory, and/or participation in production and/or class sessions, whether or not such injury or loss results from the David A. Straz, Jr. Center for the Performing Arts or its employees. It is also understood that performing arts instruction involves corrections that may include physically touching the Student as part of regular class work and rehearsals.

Visual representation and publicity: The David A. Straz, Jr. Center for the Performing Arts ("the Center") and the Patel Conservatory ("the School") shall have the right and permission to use, publish, and/or reproduce photographs, film, and videotapes taken by or for The Center or the School. All publicity during the term of this agreement shall be under The Center and the School's control, and the Student shall cooperate by engaging in such publicity and activities as directed by The Center or the School.

The Parent(s) or Guardian(s)/Student agrees to allow the Student's name, photograph, voice, image, and information to be used by The Center or the School for use in The Center or the School's publications, promotion materials, any company sanctioned marketing or advertising and website, without compensation and without prior notice. Photos are allowed to be taken of students during any open classroom or approved events. Parent(s) or Guardian(s)/Student also allows student to be interviewed by the media on campus or at school-related events. Parent(s) or Guardian(s)/Student releases and holds The Center or the School harmless from any liability stemming from the use of the Student's name, photograph, voice, image, or information.

Representations: I/we represent and warrant to David A. Straz, Jr. Center for the Performing Arts, that (i) all of my/our child's living parents and/or legal guardian(s), as applicable, have duly signed this Release (unless the David A. Straz, Jr. Center for the Performing Arts has granted a specific written exception due to unusual circumstances), and (ii) the Student has no medical condition (physical or mental) which would or could impact on David A. Straz, Jr. Center for the Performing Arts allowing the Student to participate at the Patel Conservatory in the production and/or class sessions and that the Student is physically able to participate at the Patel Conservatory in the production and/or class sessions, and (iii) the Student is not taking any herbal or medicinal supplement or prescription that could impact on the Student's participation at the Patel Conservatory in the production and/or class sessions.

Consent to medical treatment: In an emergency, when parental permission is not available, we hereby give our permission for a staff member of the Patel Conservatory to consent to medical treatment of our child and/or ward.

Student/Family Commitment: I have read and understand and will abide by the student/family commitment contract and the handbook. Violation of any policies may be grounds for immediate dismissal from the Conservatory and is at the discretion of Conservatory administration.
